

MEMORANDUM OF AMENDMENT TO TRUST DEED

This amendment to the Trust Deed executed on 27th Day of November, 1995 at New Delhi as amended by 'Memorandum of Amendment' dated 21.04.1999 by Sant Baba Mann Singh Ji, the settlor of the Trust <u>SANT BABA MANN SINGH JI CHARITABLE TRUST</u> on this 11th day of March, 2013 as under:-

This deed of Trust is executed at New Delhi between Sant Baba Mann Singh Ji,

(hereinafter shall be referred to as the settlor)

AND

- 1. Secretary General Sant Mohan Singh Ji, Gurudwara Sach Khand Ishar Darbar, Jurasi, Pehowa, Kurukshetra, Haryana.
- 2. Treasurer, Bhai Mani Singh Ji,
- 3. Trustees (Members): as per annexure "A" enclosed.

All the above hereinafter shall be referred to as the trustees.

Whereas the settlor is the absolute owner and in possession of the property detailed in the schedule attached and is desirous of creating a trust for the said property for religious, educational and social welfare purpose like organizing the Dewans to celebrate the gurupurabs, to hold and organize the free community kitchens etc., to run the model schools, colleges, universities and training academics in industrial and vocational sectors to run free dispensaries, Hospitals, labs etc. for providing the required medical aid to the needy and the poor people to contribute for the sufferers of natural calamity and to provide the financial aid to other religious and charitable organisations.

SALIENT FEATURES:

- To Spread the messages of Guru's, Saint's and connected philosopher within India

 - To celebrate birthdays, Important festivals and events relating to all Gurus and such human beings as are connected with such activities.
 - To assure formation of Free Legal Aid Cell by Sant Baba Mann Singh Ji, with a view to provide immediate and continuous relief to sufferers who need their support, cooperation, legal aids from time to time.
 - To improve from within individuals internally and externally through deep meditation, yoga and other such related spiritual activities leading to permanent and effective solutions to problems of the modern men, women, children, young, old and sick.
 - To help in realizing through upliftment of poor children, men, women, young, old and sick world over.
 - To open trust branches / chapters / offices within India and abroad.
 - To remove misunderstandings, misgivings and distrust amongst various religions of the world by organizing meetings, seminars, workshops, conferences, world sammelans, prabhat pherries and rallies, races and talks in the mornings, evenings and on various other occasions as decided by the trustees of the Board.
 - To Create World peace and unity according to the message through active involvement and of Guru Granth Sahib participation of such people who believe in better and perfect national and international integration through Sadbhawna without politicalising religion, sentiments, emotions and intellect leading to purity of heart, mind and soul.

- This List is open and could be further broadened with additions and deletions of activities as decided by the trustees from time to time.

NOW THE PRESIDENT (THE SETTLOR) HEREBY DECLARE AS UNDER:

That the trust shall be run under the name & style of SANT BABA MANN SINGH JI CHARITABLE TRUST, NEW DELHI.

That the settlor as beneficial owner of the said properties, assets as mentioned in the above title para hereto, conveys, transfers and grants upto the trust all and every such property and assets as mentioned in schedule A to have and to hold the same in trust for the objects of the trust as described below to be used and appropriate by the Trust in order to carry on and fulfill the said object in accordance with the direction of the SETTLOR so for as the same shall extend, and the settlor hereby relinguishes for all time any claim to or interest to the properties and assets mentioned in schedule a (hereinafter called collectively the subject matter of "THE TRUST".

THE OBJECTS OF THE TRUST ARE AS UNDER:

- To manage and organize the Religious Dewan, hold free community kitchens, celebrate religious Purabs etc.
- 2. To engage teachers, professors. Instructors and experts of good moral character and conduct to impart efficiently and economically up to date instruction to pupils and students of modern sciences, industrial vocations, research work, intellectual and other

- 3. To develop a healthy as well as critical attitude towards the development of mental, physical of the people.
- 4. To invest, dispose of transfer and otherwise deal with the subject matter of the trust in such manner as the trustees may deem fit so as to enable the Trust to carry on the object of the Trust effectively.
 - 5. To start charitable hospitals or promotion of health and to provide medical facilities to the poor, needy and deserving patients who cannot afford expensive treatment.
 - 6. To accept donations, grants, presents and other offering and to deal with the same for the purpose of the Trust.
 - 7. To charge moderate tuition fees or to otherwise recoup themselves for the outlay and expenses incurred in the upkeep and maintenance of institution established or about to be established under the deed.
 - 8. To train and equip the pupils so as enable them to be self supporting in an honourable and decent way of life so as to develop into good, healthy and progressive citizens through formulation of desired social attitude with assurance from parents, teachers and leaders to provide quality time to children and other such people through their own actions and examples to set healthy trends.
 - 9. To promote and include the dignity of labour, the appreciation of intellectual gifts and talents of all kinds.
 - 10. To encourage sports man/woman through active involvement and participation as well committed actions and adventurous spirit in the peoples and those connected with the institution and coming in contact with them and to participate in games of skill and
 - 11. To develop disciplinary conduct and habits to observe the rule of law and self restraint.
 - 12. To bring out, encourage and develop the incentive and research faculties of the pupils and teachers to afford opportunity for research work in art, science and industrial undertakings.

- 13. That the trustees may at the recommendation of the Trust payout such stipends and scholarships and on such terms, if any, as they may deem fit as may be in commensurate with income of the subject matter of the Trust.
- 14. That a bank account/accounts shall be opened in the name of Trust to be operated well as signature of President (the settlor the under Chapters/Branches/Registered Office/Corporate Office of the Trust).
- 15. That after defraying all necessary expenses incurred in the realization of the income of the subject matter of the Trust, the balance of the income shall be utilized for repayment of loan, if raised from any bank or private institution and keep the balance in reserve fund to be utilized in the case of emergency in accordance with the unanimous opinion of the trustees expressed in a joint meeting of the trustees.
 - 16. That the trustees may out of the corpus of the subject matter of the Trust spend such money, or out of the sale proceeds of any part thereof has considered to be appropriate besides such money or part thereof for laying out, erecting and furnishing any building, research institute or for incurring any capital expenditure as may be resolved by the
 - 17. The trustees shall have the power as well as the authority to accept donations either in cash or movable and immovable properties either with or without any special condition attached to it, provided, it does not contravene clause 1 herein above.
 - 18.It shall be competent for the trustees from time to time to frame, make and enforce all such rules, regulations and bye-laws not in consistent with the express provision of this Trust as the trustees may deem proper for securing and facilitating the administration and management in detail of the various departments relating to the activities and affairs of the Trust, and for convening, conducting and regulating the meeting of the trustees and for appointing sub committees and generally for the management and administration of the Trust estate and also from time to time to repeal, alter, amend, rescind or add to all such rules, regulations and bye-laws and also to pass resolutions in connection with or any of the said matter at their meeting.
 - 19. The president (the settlor) shall have power and authority to appoint or engage at his discretion remove, dismiss or suspend one or more secretaries, treasures, supervisors, cashiers, accountants, clerks, chowkidars, attendants (servants) and other officials or

- 20. The trustees shall also have power to formulate and maintain provident/gratuity/personnel/other funds for any employee and make rules and regulations regarding the same.
- 21. The trustees shall have power in general to acquire all things and do all acts necessary to carry out the objects of the Trust with the consent of the president (the settlor)
- 22. The trustees shall be entitled to reimburse themselves out of the Trust estate all expenses incurred in or about the execution of the Trust or powers herein or in carrying out the Trust, its objects and affairs or the realization, preservation or benefit of the trust properties. The trustees shall be entitled to be indemnified by the Trust properties, against the consequences of all lawful acts done by the trustees in the course of and discharge of their duties as the trustees of the trusts and all costs, charges and expenses thereof.
 - 23. Trustees shall not be entitled to any remuneration and shall work in an honorary capacity. They shall, however, be entitled to receive the out of pocket expenses incurred by them in the course of discharging the Trust or the travelling expenses incurred by them for attending the meetings or performing the duties to fulfill the objects of the Trust.
 - 24. That the settlor hereby appoints himself as Founder Trustee and Sant Baba Mohan Singh Ji as the First Trustee of the Trust.
 - 25. That the settlor is the Life Trustee and all Trustees shall work in achieving the objects of the Trust.
 - 26. That the minimum strength of the Board of Trustees shall be two and may be increased to any number subject to maximum of eleven at the sole discretion of the settlor.
 - 27. During the life time of the settlor, and notwithstanding the number of trustees on the Board, the general management and exercise of powers referred to in, shall vest solely with the settlor, or such other trustee (s), whom the settlor may authorized to perform specific duties on such terms as he thinks fit.

- 28. That in the event of absence of the settlor due to death/resignation or otherwise the Managing Trustee shall be the person specifically nominated in writing by the settlor/Managing Trustee for the time being.
- 29. That subject to the provisions made in this Trust Deed, the quorum for a meeting of the Board of Trustees shall be two trustees present in person and all questions at such meeting will be decided by majority of trustees present in the meeting.
- 30. That the settlor shall nominate any one out of trustees to be the Managing Trustee.
- 31. In case any vacancy arises on account of the death or resignation of a trustee, or on account of a trustee becoming unfit or incapable to act as such, or otherwise for any reason what so ever, a new or additional trustee shall be appointed by the trustees with the consent of majority of the trustees.

BANKERS

The trust may open a bank account in any Scheduled Bank.

CORPORATE OFFICE

Shall be located at Gurudwara Sach Khand, Ishar Darbar, Jurasi, Pehowa, Kurukshetra Haryana.

REGISTERED OFFICE

Shall be located at 3/15, Kalkaji Extension, New Delhi.

MONITORING & CONTROL

Each branch/chapter/regional office shall open bank account in the respective place wh maintaining account (day book, cash book, ledger, trial balance and balance shee However, as regards income tax, the same shall be followed by the corporate office on t receipt of complete details including the balance sheet from each chapter/branch/offic Budget shall be the responsibility of the respective office subject to the approval from t corporate office.

MONTHLY MEETINGS

shall be held at each chapter/branch/head office. However, president's office shall be furnished with the monthly report by 7th of the following month. Follow up action shall be assured by each concern official of the Trust.

QUARTERLY MEETINGS

Shall be held at each regional office. The minutes of such meetings shall be finally sent to corporate office with complete involvement of each chapter/branch/head office. Follow up action shall be assured by each Head of the Department at the earliest possible.

ANNUAL GENERAL MEETING

Each chapter/branch/office/regional office/corporate office shall normally hold the AGM once a year preferably during June-July. After the annual budgets expenses and income statements have been approved in the AGM, the accounts shall be finalized with the assistance of respective auditors. Consequent upon audit of accounts, budgets, formulation and balance sheet drawn, all these documents with necessary details including the signatures of all concerned and the same shall be send to registered office. The registered office shall ensure submitting combined trust income and expenditure reports (statements) to the income tax department and obtain necessary clearance certificate from the department without delay.






